Purpose of the NAAE Teacher Mentor Award Program

NAAE and other agricultural education-related organizations have identified the agriculture teacher shortage as the most challenging issue facing the agricultural education profession. Many agricultural education teacher positions go unfilled every year because local school administrators cannot find qualified persons to apply for the positions. School districts that desire to open new agricultural education programs have a difficult time doing so because often they cannot find a teacher for the new program. *Goal One* of the national Reinventing Agricultural Education for the Year 2020 project is to ensure:

“An abundance of highly motivated, well-educated teachers in all disciplines, pre-kindergarten through adult, providing agriculture, food, fiber and natural resources systems education.”

The NAAE Teacher Mentor Award Program is one initiative to address the teacher shortage issue. Specifically, the recognition program will address teacher retention. Statistics indicate that a large proportion of classroom teachers leave the teaching profession within their first five years of teaching. Beginning teachers are in desperate need of leadership and guidance during their induction years.

If you ask agriculture teachers what motivated them to enter and stay in the teaching profession, predominately they will attribute their decision to another agriculture teacher who encouraged them. Many state agricultural education associations have recognized the importance of positive relationships between beginning and experienced teachers by creating formal organizational structures to connect beginning and experienced teachers. This award program will provide additional incentives for experienced teachers to become mentors for beginning teachers, and it will provide beginning teachers a way to say thank you to the experienced teachers who have influenced them.

Awards and Recognition for NAAE Teacher Mentor Award Recipients

Each state winner will receive a sponsored plaque at the annual meeting of the state agricultural educators association. NAAE will recognize six national winners, one from each NAAE region. All state winners will compete within their respective NAAE region for the regional award. Each regional winner will receive: (1) a \$400 travel stipend for the specific purpose of attending the 2017 NAAE Convention in Nashville, Tennessee; (2) complimentary registration for the 2017 NAAE Convention; and (3) an engraved plaque.

Award Application Instructions

Eligibility: All active NAAE members, except current members of the Board of Directors and previous regional recipients of this award are eligible to enter.

Required Components of the Application:

1. Online Application – the first portion of the application must be the completed online. No other cover pages should be included. (The cover sheet is not considered a part of the page limitations.)

All items listed below should be saved as electronic files and uploaded to the online application form. Printed copies of the items below will not be accepted. Supported file types include .pdf, .doc, .txt, .jpg, .png, .gif, .tif, or .bmp.

- 2. Narrative** – the narrative is limited to five 8 1/2” x 11” pages. The narrative must be typewritten and uploaded to the online application form. Use a font no smaller than 12 points and double-space. Multiple text formats are acceptable, including paragraphs, lists, and tables. The narrative must follow the outline specified as follows:
- a. Overview of Mentoring Situations** – a description of the specific situation(s) in which the mentoring activities took place (face-to-face meetings, observations, telephone calls, etc.). (10%)
 - b. Instruction** – examples of how the mentor assisted the mentee(s) with effective classroom and laboratory instruction. (15%)
 - c. Experiential Learning** – examples of how the mentor assisted the mentee(s) with developing effective work-based learning experiences for students such as supervised agricultural experience programs, cooperative education, and internships. (15%)
 - d. Student Organizations** – examples of how the mentor assisted the mentee(s) with enhancing student leadership development through student organization activities, including FFA, PAS, and NYFEA. For adult instruction situations, provide examples of how the mentor assisted the mentee(s) in enhancing the leadership development of program participants. (15%)
 - e. Partnerships** – examples of how the mentor assisted the mentee(s) in enhancing relationships with partners such as volunteers, school and community leaders, industry leaders, and others who have the capacity to support the agricultural education program. (10%)
 - f. Marketing** – examples of how the mentor assisted the mentee(s) in marketing (or promoting) the local program to groups such as prospective students, parents, school administrators, and community leaders. (10%)
 - g. Professional Growth** – examples of how the mentor assisted the mentee(s) in staying professionally prepared and up-to-date in teaching techniques and technical content including information regarding participation in professional organizations such as NAAE and NAAE sponsored programs such as Communities of Practice. (10%)
 - h. Community-based Planning** – examples of how the mentor assisted the mentee(s) in developing the local program to meet the needs of the local community. (10%)
- 3. Letters of Reference** – three letters of reference should be uploaded to the online application form. Sources of the letters should be as follows: one letter from an administrator; one letter from an agricultural educator; and one letter from a mentee of the applicant. Letters of Reference should reference the mentoring characteristics of the applicant. letters of reference are not considered in the page limitations.) (5%)

4. **Supporting Materials** – the supporting materials are limited to five 8 1/2” x 11” pages and saved in a format that can be uploaded to the online application. Supporting materials (such as photographs with captions, news articles, and other items) must be formatted to 8 1/2” x 11.” Evaluation of supporting materials will be included with the evaluation of the components of the narrative (2.a.-2.h. above)
5. **Application Signature Sheet** – the application signature page must be signed by the requested individuals and uploaded to the online application form. The application signature page can be found on page 4 of this document.
6. **Professional Photo or Headshot** - A high resolution photo in .gif, .jpeg, .png, .bmp, .jpg, or .tif form must be uploaded as part of the online submission of your application.

Requested Components of Application:

1. **Photos Showing Instruction, Experiential learning, Student Organizations, Partnerships, and Marketing** - High resolution photos in .jpeg, .png, .bmp, .jpg, or .tif form can be uploaded as part of the online submission of your application.

State-level Competition

When and Where to Submit: Entries must be submitted to the state association by the deadline established by the state association.

Evaluation Procedures: Each respective state association will determine the selection process for state winners.

National-level Competition

What to Submit: All required components of the application must be submitted online by May 15. No printed or emailed applications will be accepted.

State presidents will authenticate state winners using the NAAE State Winners’ Validation Form” provided to them by NAAE. All state winners must be authenticated by May 15.

Evaluation Procedures: The evaluation of applications will be completed electronically. Applications will be judged by NAAE regions on a rotational calendar. A committee appointed by NAAE will select regional winners.
